

Trip Report: Winter Paddle

Winter has finally arrived in RI! The thermometer registered a brisk 16 degrees as I was loading the boat on the car to paddle with Joe out of Jamestown. The forecast was for temps in the low 30's later, so I figured to tough it out in the morning and the afternoon shouldn't be too bad.

The bay was like glass at the put-in, but winds were expected to reach 10-15 kts in the afternoon. We opted to paddle out towards Rose Island and then down towards Castle Hill so we would have wind and tide at our backs for the return trip.

Rounding the north end of Rose, we could see about 20 or so seals both in the water and on the rocks. We kept a respectful distance from the seals on the rocks and some went into the water and some just kept lying on the rocks. A HUGE gray seal just seemed to watch the goings on like a king watching over his subjects. Joe suggested we paddle backwards, and as we did so, they just kept getting bolder and bolder, coming within just a few yards of us, It was really cool to see how unafraid and curious they were. absolutely see expressions of curiosity on their faces! Winter paddling rules!!

We turned around and continued on down towards Castle Hill and Brenton Point. The mouth of the bay was as calm as I have seen it, with just a gentle swell rolling in from the Atlantic and a few small breakers on the reefs. We rounded the point and stopped at a small beach for lunch.

While launching after lunch we noticed what we thought was one seal splashing around between reefs . As we paddled past, we saw that it was two seals playing and wrestling in the waves. We stopped to watch, and they kept getting closer and closer, still completely oblivious to our presence. They really were into their play, much like human kids. They drifted to within 5-6 yards of us when suddenly one noticed us. The expression on this animals face was priceless. Its eyes got big as saucers before it slapped its tail and was gone. I will never forget the look of surprise as long as I live...I personally have never believed that marine mammals were as intelligent as people say, but after seeing the shocked look on that seal, I believe now!

The wind picked up some as we headed back to the cars and it began to snow lightly. The bay was a completely different body of water from the summer bay. There were no other boats on the water except for an oil tanker and the Block Island ferry. Everything was peaceful and quiet. The snow seemed to mute all the colors along the shore and there were incredible ice sculptures on the rocks and cliffs from waves caused by the gale force winds of the day before freezing in the cold temps. I got back to the car a little tired in my body, but completely renewed and refreshed in spirit. A very memorable paddle. WINTER PADDLING RULES!

Author's note: Although we did get close to the seals it is important to note that we did not intentionally approach to within more than a couple of hundred yards. All the seals approached us either to get a closer look at us or because they did not notice us. It is against federal law to

Seals protected by law—and teeth

They're dog-tired by the time they get here - you would be too if you just swam from Labrador or Newfoundland. So they haul out onto the beach for some R and R, and that's when their troubles can begin.

This is the time of year that juvenile hooded and harp seals, Arctic species that spend most of their lives in the far reaches of the North Atlantic, visit New England in search of food. They are fairly common and cute as a button, but resist the urge to get too close. You're risking their lives, your safety and a substantial fine to boot.

"The Marine Mammal Protection Act makes it illegal to have any contact with seals," said Mason Weinrich, executive director and chief scientist at the Whale Center of New England in Gloucester. "It's not only good practice, it's illegal to approach them."

Seals can show up on any local beach, and it's not uncommon for them to hang out for a couple of days. They tend to gorge themselves when feeding, then rest until they're hungry again. That can lead people to believe the animals are in distress when they're not.

What does strain them is human beings getting too close. Because they have so little contact with people, they don't know whether we're predators or not, said Franz Ingelfinger, an ecologist with The Trustees of Reservations, which owns Ipswich's Crane Beach, a popular spot for seals to haul out.

"They're somewhat naive,"



approach or harass marine mammals. The stress of people trying to get too close has been shown to have a negative impact on marine mammals. We would not have had the encounters we did if we had tried to. The seals would have kept their distance if we had tried to get too close.

Ingelfinger said. "They never see people, so they don't run away."

Nonetheless, their hearts race and they are stressed, he said, and burn energy that is in short supply during the winter.

Weinrich said repeated approaches by humans can even start seals on a downward cycle that ends in their death.

With their deep, black eyes and otterlike faces, seals are irresistible to most people, but that doesn't mean they aren't wild animals. Approaching too close could seal your fate.

"They could strike out and bite you," Weinrich said, and they carry diseases that can be transmitted to humans. They may look awkward on land, but they can be deceptively quick.

Adam Kennedy, a biologist at the New England Aquarium in Boston, said he's always perplexed by people who wouldn't think of approaching a bear in the forest but don't fear getting close to a seal.

"It's a little mind-boggling sometimes," Kennedy said.

Ingelfinger said one of his park rangers intercepted a woman last weekend who wanted to put her young child down right next to a seal. Experts recommend you stay at least 50 yards away from seals.

Kennedy said most seals sunning on a beach are more than likely just fine. Those that aren't are sometimes rescued by aquarium staff, but it's a tough call.

It takes 13 or 14 people to capture a 700-pound hooded seal," he said. "It's really stressful and can put them in shock." That can turn a rescue into a death sentence, so biologists are cautious about taking that step.

So if you plan to walk the beach, bring your binoculars and get a close-up view of a beached seal from a safe distance.

"It's an opportunity to take nature in," Kennedy said. "They don't always come down here."

If you think a seal needs help

If you find a seal with an obvious injury or that looks like it's in distress, call the Whale Center of New England at 978-281-6351. Its staff can evaluate the animal and determine if it should be moved. The phone is monitored 24 hours a day.


